### ELIGIBILITY

Professional and amateur artists 18 years and older are invited to submit work. All work must be original (no giclee prints) and have been completed within the past 36 months and never entered in Annual Juried Show.

Artists need not reside in the State of Ohio to submit works of art.

### DELIVERY

Delivery of artwork is to be made by artists to BAYarts March 3<sup>rd</sup> from 12 – 5 pm or March 5<sup>th</sup> 10 – 3pm to the Fuller House Sullivan Family Gallery. Only those artists whose work has been accepted will be notified.

Notification will be made no later than March 7th. Work that has been accepted cannot be removed until after the exhibit has closed.

### PICK UP

Only those artists whose work has been accepted will be notified.

Pick up of work that has not been accepted must be picked up on March 7-8 from 10 – 4 or by appointment.

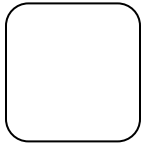
### ENTRY FEES

An entry fee of \$20 for members and \$30.00 for non-members for up to two (2) works may be submitted.

### ENTRY RULES:

List works submitted in the space provided below. Entries may not exceed 5 feet in width and/or length. All paintings, prints or drawings must be backed, dry and/or wired for hanging. Any work deemed by BAYarts to be too fragile for public display or not wired sufficiently will not be accepted. NO SAWTOOTH HOOKS PLEASE. A label must be attached to the back of each piece of work. The label must contain the name of the piece of work, the artist's name, address, telephone number, medium and price.

**Price should include BAYarts' 40% commission.**

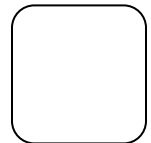
